

## WARRIORS LEGACY ENDOWMENT SCHOLARSHIP

*In 2009, the Henry Wise Wood Parents and Alumni Association established this endowment legacy fund to honour graduates of Henry Wise Wood school, and to create a community opportunity to award outstanding students in their various accomplishments through their high school contributions.*

**DONOR:** Henry Wise Wood Parents and Alumni Association

**WHERE TENABLE:** Henry Wise Wood High School

**FIELD OF STUDY:** Unrestricted

**VALUE:** \$500

**NUMBER:** *In each of 2010 and 2011:* Five awards, one in each area of: Academics, Athletics, Fine Arts/Drama, Citizenship/Community Spirit, Most Improved Student

**ELIGIBILITY:** Open to students registered in grade 12 at Henry Wise Wood High School who are completing the requirements of a high school diploma. Applicants must have marks sufficient for entrance to a post-secondary area of study.

To be considered for this award, applicants must:

1. Demonstrate outstanding ability, achievement, leadership, citizenship, and excellence of service to the school and community throughout Grades 11 & 12.
2. Demonstrate goals and a future plan, plus strong personal skills and character, overall good attitude.
3. The recipient(s) must not hold any other scholarship(s) or award(s) in excess of \$2,000 individually or \$4,000 cumulatively, with the exception of the Alexander Rutherford Scholarship and any post-secondary entrance awards. Students must notify EducationMatters of other awards won.

Selection will be based on staff recommendations and confirmation of pursuit of post-secondary education, with a preference for students with financial and socio-economic need and/or other special circumstances specific to that student / family.

**APPLY:** Applicants should complete the EducationMatters **School-Specific Application for Awards**. Complete application packages should be submitted to the Scholarship Coordinator at the Applicant's high school.

**SELECTION &** Recipients are notified by September. To claim the award, within **twelve (12)**

**PAYMENT:** **months of notification of award**, the recipient must be registered in an eligible program of post-secondary study **in Canada** of at least **two years duration**. Payments are made to the post-secondary institution.

**DEADLINE:** Normally **May 30** to the Scholarship Coordinator at the Applicant's high school. Applicants should check with their Guidance office for application deadlines in their school.


Please print or type all applications in black ink. This application will be used to evaluate students for academic awards with EducationMatters. Application forms must be submitted directly to your High School Scholarship Coordinator or School Principal normally by May 30, 4:30 p.m.


**SECTIONS I and VI must be completed for EACH School Specific Application for Awards. Only complete Sections II, III, IV and V if the specific scholarship requires that information.**

This application has **six** Sections:

- **Section I** contains the basic personal and educational information
- **Section II** is on a separate page and contains information about school activities. It is only required for those awards that have **school activities** as a criteria of eligibility
- **Section III** is on a separate page and contains information about **community, personal and volunteer** activities. It is only required for those awards that have community of leadership criteria required in the eligibility
- **Section IV** is on a separate page and is to be used for those awards that require a personal statement or a written essay on a particular topic or essay.
- **Section V** is the financial information required if you are applying for a Bursary
- **Section VI** contains the High School Counselor endorsement and the applicant's certification and signature page.
